Purpose of the Post:

Your role will be to spearhead campaigns to change the community perceptions of food aid projects. To move away from the idea of giving food is enough, towards build a collective vision for a time when food aid is no longer needed.

You will be responsible for supporting service users to share their stories and contributions with decision makers. In so doing, creating a space for co-commissioning that focuses on the drivers rather than the results of poverty.

You will build and manage relationships with service users, colleagues, decision makers, faith groups and community groups both in person and over digital channels. Your actions and engagement will assist Pecan to help transform the lives of the most disadvantaged people in our community.



Main responsibilities

Research

- 1. To explore and understand the experiences that are bringing people to need the food bank's support.
- 2. To map out and build relationships with the food bank's partners.
- 3. To identify a local issue driving poverty, build a campaign team and develop a strategy to build power and win change.

Campaigning

- 1. Set up and coordinate processes and relationships that bring service users into decision making structure for food projects, Pecan and the wider community.
- 2. To develop and deliver the local influencing campaign mobilising local faith groups, community groups, local authorities and commercial organisations.
- 3. To engage in Trussell Trust's central priority campaign activities, working with the food bank and local community.
- 4. To develop and mobilise a team of volunteers who can drive the campaigns, establish a project steering group within the food security projects that will focus on local influencing to reduce poverty and the need for food banks.
- 5. To work with the marketing team in Pecan to run campaigns on poverty and food insecurity, both in person and across all digital platforms including social media and websites.

Networking

- 1. To build relationships with community partners with a focus on influencing attitudes towards food security and the drivers of poverty.
- 2. To work with the Trussell Trust OLM team and engage with the training and support on offer, including work with other local organisers in the Trussell Trust network.
- 3. To be an active participant in the Southwark Food Action Alliance. Working in partnership with other members and the local authority to build a coalition around the aim to 'end the need for foodbanks'. This will involve taking part in ad-hoc activities and projects.



Wider organisational responsibilities

- Attend Pecan team meetings as and when required, including meetings where there may a time of prayer and reflection.
- Read the core policies and adhere to all policies and procedures.
- Carry out other duties as agreed by the Chief Executive Officer.
- Undertake responsibilities associated with being a member of the Pecan team.
- Perform all the duties required by the post in line with Pecan's ethos and values statement, its commitment to a policy of equal opportunity and its aim of serving the community in a caring and practical manner.
